The combination of tourist services offered to you constitutes a holiday package event as defined in the Directive (EU) 2015/2302.

As a result, you will enjoy all the EU rights applicable to package holidays (the term "participants" is to be used interchangeably with the term "travellers" as it appears in the EU directive, provided in the form of a link at the end of this form).

The LOVE FOR RIDE travel agency Adam Dąbkowski (hereinafter referred to as the Travel Agency) will be fully responsible for the proper execution of the entire holiday package. In addition, in accordance with legal requirements, the travel agency possesses guarantees to ensure the refund of your payments and, if transport is part of the package, your return to the country in the event that the travel bureau becomes insolvent.

Key rights under Directive (EU) 2015/2302

- Before concluding a contract of participation in a tourist event, the participants will receive all necessary information about the tourist event.
- At all times at least one entrepreneur is responsible for the proper execution of all contractual tourism services.
- The participants are provided with an emergency telephone number or contact point for contacting the tour operator or travel agent.
- Participants may transfer the holiday to another person within a reasonable period of time, subject to any additional costs.
- The price of the holiday package may only be raised if certain costs (e.g. fuel costs) have increased and this is expressly stated in the contract; under no circumstances may the price increase take place more than 20 days before the start of the holiday.
- If the price increase exceeds 8% of the holiday price, the participants may terminate the contract. If the tour operator reserves the right to increase the price, the participant is entitled to a discount if the corresponding costs become lower.
- Participants may terminate the contract without incurring any cancellation charge and obtain full reimbursement of any payments if any significant change in a substantial part of the package, other than the price, occurs. If the tour operator cancels the holiday before it begins, participants shall be entitled to reimbursement and, where applicable, to compensation.
- In exceptional circumstances for example, if there are serious safety issues at the final destination which may affect the holiday -participants may, before the start of the holiday, terminate the contract without incurring any cancellation charge.
- Furthermore, participants may terminate the contract at any time before the start of the holiday for an appropriate and justifiable fee.
- If, after the start of the package, significant elements of the package cannot be provided in accordance with the contract, the participant will have to be offered adequate alternative services at no additional cost. If the services are not provided in accordance with the contract, which significantly affects the realisation of the holiday and the tour operator fails to remedy the problem, the participants may terminate the contract without charge for termination.

- The participants are also entitled to a discount or compensation for damage in the event of non-performance or inadequate performance of the tourist service.
- The tour operator must provide assistance to participants if they encounter difficulties. Polish Journal of Laws 31 Item 2361
- In the event that the tour operator becomes insolvent, the payments will be refunded. If the tour operator becomes insolvent after the start of the holiday and the holiday includes transfers, return transfer to their home country will be provided for participants.
